SCRAM Remote Breath®

Corrections-grade breath testing for lower-risk offenders or those who have earned less intensive monitoring.

- Flexible testing frequency with scheduled, random, and on-demand options to support your program's supervision model
- Automated facial recognition prevents clients from circumventing their testing and reduces manual review of photos by 90–95%
- Immediate notification of BrAC and client ID for quick responses to client actions
- GPS locations with taken and missed tests provide additional supervision data
- STORE & FORWARD functionality ensures every test result is captured and reported

SCRAM Continuous Alcohol Monitoring®

Around-the-clock transdermal alcohol monitoring—the best option for higher-risk alcohol offenders.

- Tests every 30 minutes, 24/7, so high-risk clients can't drink around a testing schedule
- Goes where the client goes, eliminating the chance to forget or miss a test
- Includes optional house arrest at the flip of a switch for increased supervision during high-risk times
- Results are single-source admissible—no back-up tests required
- A validated alternative to incarceration to allow clients to remain in the community and meet their work and family obligations

HIGHER-RISK ALCOHOL CLIENTS



- Frequently abuse alcohol, or are addicted or dependent
- Hardcore, repeat offenders and those with a high BAC at time of arrest
- Account for the most serious alcohol crimes and related costs
- Require more intensive supervision and longer-term monitoring
- Need true behavior modification to reduce risk of recidivism
- Undeterred by incarceration, fines, or the loss of driving privileges

MID-RISK ALCOHOL CLIENTS



- Often misuse or periodically abuse alcohol
- Highly susceptible to becoming higher-risk clients
- History of multiple alcohol-related offenses
- Likely to require additional services and support to address alcohol issues
- Show repeated non-compliance with less intensive monitoring, such as point-in-time testing
- Benefit from step-down supervision following Continuous Alcohol Monitoring

LOWER-RISK ALCOHOL CLIENTS

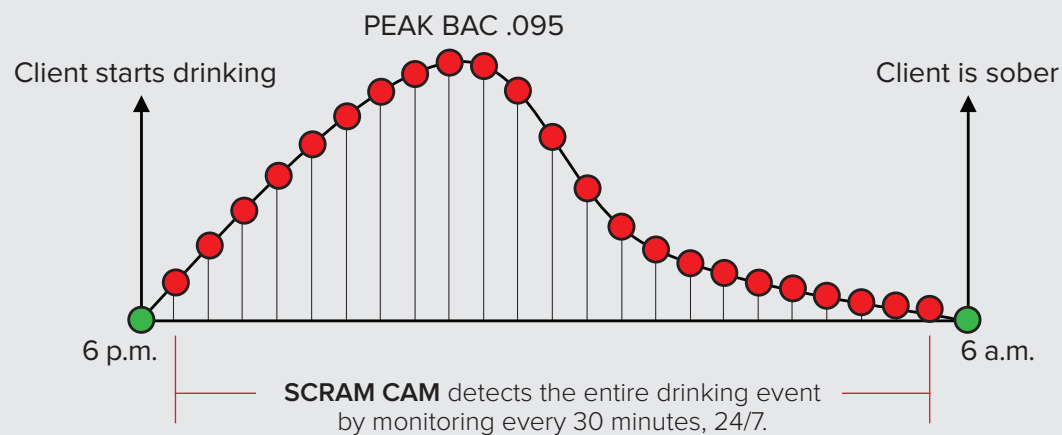


- Occasionally misuse alcohol
- First time offenders and those with a lower BAC at time of arrest
- Are more likely to be involved in public disorder and non-violent offenses than individuals who do not misuse alcohol
- Represent the majority of alcohol-involved offenders in the system
- Assessment shows a lower risk of recidivism
- Have a strong support system and ties to the community or family
- Require less intensive supervision



SCRAM CAM®

- The only technology that ensures Sober Days™—not just sober moments
- Proven to support true behavior change in alcohol-dependent clients
- An effective sanction for clients who violate point-in-time testing requirements
- Works in conjunction with treatment to enforce compliance and identify when intervention may be needed



SCRAM Remote Breath®

- Proportional sobriety monitoring for first-time and lower-level offenders
- Device-initiated testing and optional text reminders ensure clients always know when it is time to test
- Provides transitional supervision for clients who have successfully demonstrated sobriety with SCRAM CAM

- Reduce reoffense and prevent escalating behaviors

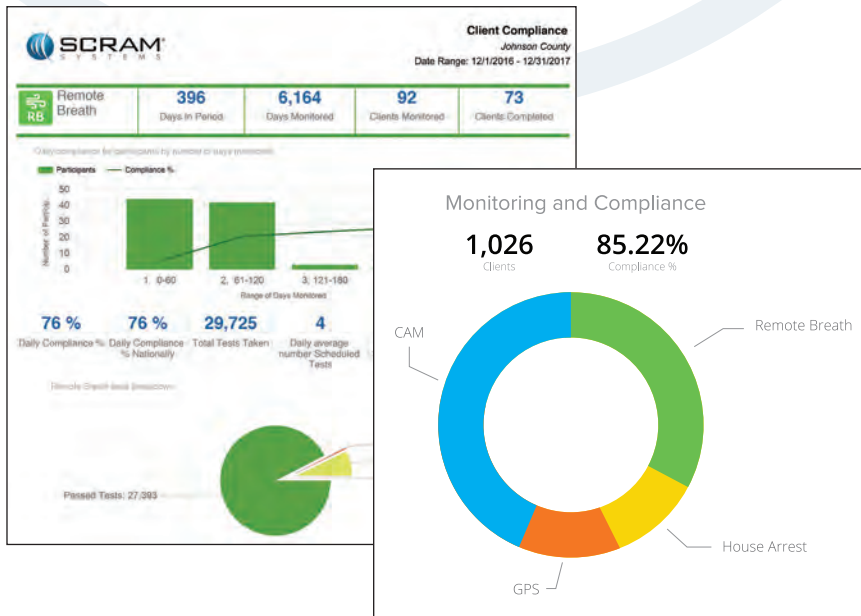
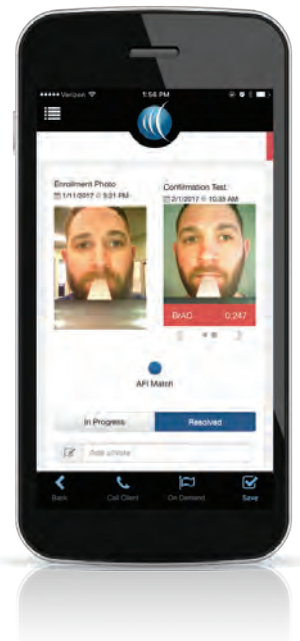
